3. Rate should be quoted inclusive of all applicable taxes and applicable taxes will be deducted at source against which necessary tax deduction certificates will be issued as and when required.
4. The work is to be done to the full satisfaction of the Officer in-charge & Engineer in-charge.
5. All tools and plants are to be supplied by the contractor himself at site.
6. Construction materials mentioned in the specification will have to be supplied/ installed by the contractor at site conformity to the specification and satisfaction to the Engineer In-charge. Sub standard materials will not be allowed to use under any circumstances.
7. Curing of construction materials be done properly and water required shall have to be arranged by the contractor himself at site.
8. No extra payment for carrying of materials will be allowed from the Council.
9. All works must be completed within three month from date of signing of F2 agreement.
10. The contractor will be allowed to make temporary shed at the work site for storing goods at their own risk if necessary.
11. Security deposit of 10% which include E/M will be released after six months from successful completion of entire works.

12. Estimates are prepared as per schedule of Rate 2010-2011 (P.W.D – Building and Electricity)
13. The bidder should submit their Technical bid and Financial bid separately.
