- Item No.1** Inaugural Refreshment:. Kaju Borfi, Small kachuri ,Banana, Biscuit, & Tea. Single rate against these items are to be quoted.
- Item No.2** Lunch (Buffet) : Rice (Aizong), Mix Dal (Mug, Masur & Chana Dal), Dry Fry (Seasonal) Mixed Vegetable (Seasonal), Chicken with Curry, Fish with Curry, Pickle, Salad, Chanti, Allo Pitika, Sweet, Curd & Mineral water. Single rate against these items are to be quoted.
